

LAKE PIRE RECREATION AREA FISHING TOURNAMENT APPLICATION

Instructions:

- 1. Complete all information requested.
- 2. Submit a copy of your club, event or tournament rules with this application.
- 3. Club, event or tournament organizers must submit a copy of the organization's State Take Permit along with applicable insurance documents. Please see Page 2 for insurance requirements.
- 4. Club, event or tournament participants are subject to all local, state and federal fishing regulations.
- 5. Club, event or tournament applications must be submitted at least 14 days prior to the start date of the event or tournament.
- 6. Nighttime clubs, events or tournaments are subject to a permit fee. Night fishing event or tournament permit fees are \$250 for small events (fewer than 50 boats) and \$400 for large events (50 or more boats). In addition, each participating boat and vehicle will be subject to the standard Lake Piru Recreation Area entry fee. The fee shall be paid the day of the event.
- 7. All boats participating in the event or tournament shall undergo a vessel exit inspection prior to departure from the Lake Piru Recreation Area.

Special Event/Tournament Insurance Requirements

Permits for groups wishing to conduct an event/fishing tournament on the waters of Lake Piru will only be issued after receipt of a certificate of insurance and insurance policy endorsement naming United Water Conservation District and Parks Management Company, their officers, employees, volunteers, elected officials and members of boards and commissions as ADDITIONAL INSUREDS of an insurance policy having a minimum coverage at all times of \$1 million General Liability and \$1 million Property Damage. Said insurance shall apply as primary insurance and no other insurance maintained by the Additional Insured will be called upon to contribute with insurance provided by this policy. The policy must state "United Water Conservation District and Parks Management Company must be provided 30 days advance written notice of any change in coverage or cancellation." Any exceptions to the above must be approved in writing by the United Water Conservation District Deputy General Manager.

Please note an insurance certificate must be accompanied by an insurance endorsement naming both United Water Conservation District and Parks Management Company as additionally insured. This endorsement shall accompany the said insured's certificate of insurance which shall also name both UWCD and PMC as additionally insured.

Special Event/Tournament Rules

- 1. All participants shall wear a USCG approved personal floatation device beginning one half hour prior to sunset and continuously wear the device until either the event is over and the participant is off the water or until one half hour after sunrise.
- 2. All vessels shall adhere to a strict 5 mph speed limit beginning one half hour prior to sunset until one half hour after sunrise or until their event is over.
- 3. All vessels shall display the appropriate USCG approved navigation lighting including begin one half hour prior to sunset until one half hour after sunrise.
- 4. All participants shall adhere to all other local, state and federal rules and regulations pertaining to fishing, boating and recreational activities.
- 5. No fishing allowed within 50 feet of the marina docks.
- 6. No fishing allowed inside of the delineated area surrounding the Lake Piru Water Treatment pump barge
- 7. No fishing allowed inside the delineated area near the Santa Felicia Dam spillway.
