1.2 Sexual Harassment Prevention Training – Dennis Timoney, SDRMA Information Item

AB 1825 (Government Code §12950.1) requires that employers having 50 or more employees shall provide at least two hours of training regarding sexual harassment to all supervisory employees in California every two years. An employer shall also include prevention of abusive conduct as a component of the training.

1.3 Biennial AB 1234 Training – Dennis Timoney, SDRMA Information Item

AB 1234 (Government Code §53235 <u>et seq.</u>) requires elected and appointed officials and designated employees to take at least two hours of training in general ethics principles and ethics laws relevant to public service at least every two years if they receive compensation for their service or are reimbursed for their expenses.
